

## Regulation of Joint Graduate School of Energy and Environment On Health Benefits of Practitioner B.E. 2550

By virtue of Article 18(2) the University Rule on Establishment and Operation of the Joint Graduate School on Energy and Environment B.E. 2541 together with the resolution of the Board derived from the meeting of 3/2550 dated 27<sup>th</sup> September 2550 hereby cancels Regulation of Joint Graduate School of Energy and Environment On Health Benefits of Practitioner B.E. 2550 and use this Regulation instead.

- 1. This regulation shall be called "Regulation of Joint Graduate School of Energy and Environment on Health Benefits of Practitioner B.E. 2550"
- 2. This regulation shall come into effect on 1st October 2550 onward
- 3. Claimable health treatment expenses should follow the following guidelines;
  - 3.1 Those who are entitled to this right shall be lecturer and staffs who are under employment contract
  - 3.2 Those who are entitled to this right shall be include spouses and legitimate child of 3.1
  - 3.3 Legitimate child of 3.2 must be not over 20 year of age
- 4. Health treatment expenses which can be claimed must be a treatment from public hospital, municipality, state enterprise, Thai Red Cross or private hospital. Joint Graduate School shall not paid for any expenses incurred from polyclinic, clinic and pharmacy
- 5. Financial amount and criteria of health treatment expenses shall be specified by Regulation of Joint Graduate School
- 6. All staffs shall be entitled to claim payment on Health Benefits of Practitioner as paid but no more than 35,000 Baht annually. For continuous treatment for serious disease shall be entitled to claim as paid no more than 120,000 annually exclude from regular health treatment depends on fiscal year
- 7. Health treatment expenses from (4) referred as a regular treatment included operation fees, necessary checkup, blood test, medicines as well as stimulant treatment due to doctor's compliance, oxygen, overnight room for patient, meals during treatment period, acupuncture treatment and maternity expenses excluding specialist and special nurse expenses
- 8. Health treatment expenses for cases hereinafter will not be entitled to claim
  - 8.1 Plastic surgery
  - 8.2 Visual acuity test for eyeglasses or wear a contact lenses
  - 8.3 Venereal disease
  - 8.4 Artificial abortion, birth control, sterilization, pregnancy and infertility treatment
  - 8.5 Alcohol, liquor, drug and addictive substance

- 8.6 Illness which cause or effect from venereal disease, alcoholism and addiction disease
- 8.7 Periodontal disease except teeth cleaning, tooth extraction, tooth filled, root canal treatment, ingrowth teeth and disease
- 8.8 Injury or illness which derives from willfully or willingly allow other cause such injury or Illness
- 8.9 Disease prevention or diagnosis which is not related to illness
- 8.10 Artificial organs or equipment for treatment
- 8.11 Injury or illness which cause by intentionally join riots or insurgent
- 9. To claim health treatment expenses, staffs must prepaid and thereafter receive reimburse from the Joint Graduate School upon your presentation of original receipts and medical certificate
- 10. The Director shall be in charged of this Regulation. If there any concern issue, decision would be final and binding.
